4. According to sub-regulation (1) & (3) of Paragraph 5 of scheme I of Schedule II under Bureau of Indian Standards (Conformity of Assessment) Regulation, 2018, the annual licence fee of Rs. 1000.00 and the marking fee for use of standard mark as per Annexure-I of Scheme I of BIS (Conformity assessment) Regulation 2018 is payable by you with effect from 2025-07-08 for the period of validity of the licence in advance.

With a view to streamlining the reporting of quantity marked, calculation and collection of marking fee on the unit rate basis, fees will be calculated on the production marked during the first nine months of operation of the licence at the time of first renewal, and on the production marked during twelve months comprising the last three months of the previous operative year and the first nine months of the current operative year, at the time of the second and subsequent renewals. - (1) मानक चिन्ह का डिजाइन अनुज्ञप्ति में दी गई प्रतिकृति के आनुषंगिक होगा।
- (2) मानक चिन्ह के फोटोग्रफिक विस्तार अथवा लघुकरण का उपयोग भी किया जा सकता है, जब तक ब्यूरो द्वारा कोई अन्य विनिर्दिष्ट न दिए गए हों ।
